Naloxone Trainings:

Justin Moore and Luis Lopez from HRC will be presenting Naloxone trainings in both English and Spanish. The presentations will rotate every 15 to 20 minutes. They will also create posters and distribute free Naloxone. Look for Justin Moore, who will be wearing a bright lime green hat!



Health Fair Flyers:
