# SPOTLIGHT SPEAKERS:

### Public Health provided insights to all the programs which are housed in the building:

- Safe Routes to School: Haylee discussed public health programs focused on promoting injury prevention and creating safe routes to school for students. These programs aim to enhance community safety through strategic partnerships with local schools and municipalities.
- **Healthy Brain Initiative:** They also highlighted the Healthy Brain Initiative, which focuses on raising awareness and providing resources to support brain health, particularly in aging populations, aiming to reduce risks associated with cognitive decline.
- **Oral Health Program:** Angela highlighted the Oral Health Program which provides education and assessments for kindergarten students, and there are plans to offer free cleanings and sealants next year with parental permission. This initiative focuses on improving children's dental health through preventative care.
- **Tobacco Education Program**: TUPE works on policy development and community engagement to reduce the harms of tobacco use. The program is involved in creating awareness about the dangers of tobacco, with a focus on youth and vulnerable populations, and working on tobacco retail policies to curb illegal sales







of flavored tobacco products. Anna explained the plan to implement a tobacco retail license in unincorporated Butte County. The goal is to ensure local enforcement and compliance checks, particularly focused on reducing the sale of illegal flavored tobacco products. This initiative is crucial for protecting rural youth, who are at higher risk for tobacco use.

• Youth Cannabis Taskforce- Kathryn provided details regarding the youth cannabis task force to increase awareness and protect youth from access to and promotion of cannabis use for youth prevention. Next meeting is Dec 4<sup>th</sup> @ 4PM virtual meeting typically after the Nicotine Action Alliance meeting.
